**SECTION 4: FIRST AID MEASURES**

**4.1 Description of first aid measures:**

Request medical assistance immediately, showing the SDS of this product.

**By inhalation:**

Remove the person affected from the area of exposure, provide with fresh air and keep at rest. **5.1 Extinguishing media:**
